XII. City Council Updates- Each Councilmember gave updates on their activities since the previous council meeting.

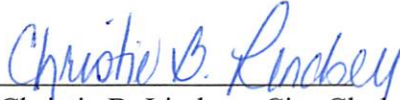
Councilmember Brown made a motion to adjourn to Executive Sessions. Councilmember Littlejohn seconded the motion, which carried unanimously 7 to 0.

AN ORDINANCE

TO PROVIDE FOR THE ADOPTION OF A CITY OPERATING BUDGET, ITS EXECUTION AND EFFECT, FOR THE FISCAL PERIOD JULY 1, 2024 THROUGH JUNE 30, 2025

BE IT ORDAINED By the Mayor and Members of Council of the City of Spartanburg, South Carolina, in Council assembled:

SECTION 1. In accordance with Sec. 2-139 of the Code of the City of Spartanburg 1988, there is hereby adopted for the fiscal period July 1, 2024 to June 30, 2025, an operating budget for the City of Spartanburg, South Carolina based on budget estimates of various funds as prepared by the City Manager and incorporated into the 2024 - 2025 budget document.

SECTION 2. The total revenues and expenditures for the fiscal period are estimated as follows:

SECTION 3. Within each fund, the City Manager shall have the authority to transfer appropriated funds within any of the designated expenditure categories, and such transfers shall be entered on the books of the account of the City. Within each fund, the City Manager also shall have the authority to transfer funds across departmental accounts to implement salary adjustments and staff reorganization. The City Manager is authorized to approve job titles, pay grades, establish evaluation points, and make salary adjustments after review by the Human Resources Director and within the amounts appropriated within this budget.

SECTION 4. An official copy of the budget document containing detailed schedules which support the appropriations set forth in Section 2 above, shall be attested by the City Clerk and maintained as an official record of the offices of the City Manager, Budget Director, and City Clerk.

SECTION 5. The sums appropriated and set forth in the detailed schedules for personal services shall be paid in accordance with the current pay plan, or as shown in the budget for those positions not classified under the pay plan.

SECTION 6. All sums received by the City of Spartanburg from any source whatsoever, unless by law designated for some special fund or purpose, may be used in meeting disbursement for the General Fund, as described in Section 2 above.

SECTION 7. All fees, income, and funds not specifically allocated in the budget for the fiscal year beginning July 1, 2024, and ending June 30, 2025, shall become a part of the General Fund of the City of Spartanburg and shall be used for general corporate purpose of the City as may be authorized by the City Manager and City Council from time to time.

SECTION 8. The City Manager is authorized to make emergency expenditures from the Fund Balance for general corporate purpose of the City of Spartanburg in an amount not to exceed Ten Thousand and No/100 Dollars (\$10,000); PROVIDED, HOWEVER, any expenditures from the Contingency shall be reported to the City Council in writing.

SECTION 9. The City Manager is authorized to inform the County Tax Collector, or such other officer of the County as may be appropriate, to levy such ad valorem millage as will be reasonable and appropriate to provide the ad valorem revenue reflected in the approved budget.

SECTION 10. The City Manager is hereby authorized to arrange for the issuance of tax anticipation notes from time to time in anticipation of receipt of taxes by requesting bids for the issuance of such notes from such financial institutions as he shall determine. The aggregate amount of tax anticipation notes authorized here under to be issued by the City shall not exceed Three Million and No/100 Dollars (\$3,000,000). The notes shall be issued in compliance with State and Federal law. The notes are designated as qualified tax-exempt obligations under Section 265(b). The City Manager is authorized to award the notes to the financial institution offering the lowest rate of interest to the City and to name the Paying Agent for the issue without further action of the City Council. Upon the specific approval of City Council, the note shall be executed by the Mayor or the City Manager and be attested by the Municipal Clerk.

SECTION 12. The City Manager is authorized to approve all local, state, and federal grant awards.

SECTION 13. This Ordinance shall become effective July 1, 2024.

AN ORDINANCE

TO RAISE REVENUES FOR THE CITY OF SPARTANBURG FOR THE FISCAL YEAR 2024 - 2025 TO LEVY TAXES ON ALL REAL ESTATE AND PERSONAL PROPERTY, EXCEPT SUCH AS IS EXEMPTED BY LAW, IN THE CORPORATE LIMITS OF THE CITY OF SPARTANBURG FOR CORPORATE PURPOSES FOR THE FISCAL YEAR 2024 - 2025 AND TO PROVIDE PENALTIES FOR THE DELINQUENT PAYMENT OF TAXES LEVIED AND PROVIDED FOR.

BE IT ORDAINED By the Mayor and Members of Council of the City of Spartanburg, South Carolina, in Council assembled:

Section 1. That an annual tax for corporate purpose and to defray the expenses of the City of Spartanburg, South Carolina, from the 1st day of July 2024 to the 30th day of June 2025, both inclusive, is hereby levied and provided for in the form and manner following:

Section 2. There shall be paid on each One Thousand and No/100 Dollars (\$1,000.00) of the assessed value of all real estate and personal property, except such as is exempted by law, in the corporate limits of the City of Spartanburg, and in proportion on less than One Thousand and No/100 Dollars (\$1,000.00) assessed value the following amounts:

For all other general corporate purposes
And requirements of the City, the sum of
Ten and 32/100 Dollars.....\$10.32

Total for all purposes, the sum of
Ten and 32/100 Dollars.....\$10.32

Section 3. In the event any of the amounts levied above for special purposes shall exceed the amounts required therefore, such excess shall revert to the General Fund and be used for general corporate purposes as City Council may direct.

Section 4. City taxes for the Fiscal Year 2024 - 2025 shall be due and payable by the 17th day of January 2025, inclusive, without penalty.

Section 5. Any persons, firms, or corporations failing to pay any tax levied hereunder when due under the terms of this Ordinance shall be subject to a delinquent penalty as established by State law.

AND PROVIDED FURTHER That, in the event any tax levied hereunder be not paid prior to March 15, 2025, the same together with any penalty thereon shall be placed in execution in the form and manner provided by law under the seal of the County Treasurer for Spartanburg County and thereupon shall be due and added such other costs, fees, and charges as are provided by State law in such cases.

Section 6. If any provision of this Ordinance or the application thereof to any person or circumstance, is held invalid, the remainder of this Ordinance and the application of such provision to other provisions or circumstances shall not be affected thereby.

Section 7. This Ordinance shall become effective July 1, 2024.

SUBJECT: Transfer of Property – Northside Neighborhood

DATE: June 10, 2024

BACKGROUND:

As part of the Northside Transformation Plan, the City of Spartanburg has in certain instances partnered with non-profit developers to build housing in the community. Staff is requesting approval to transfer property to the Northside Development Group (NDG) for the development of mixed income housing on several properties in the Northside. The NDG has engaged a development team with Homes of Hope, a statewide Non-profit community development organization to develop 43 homeownership and rental units in the Northside neighborhood. The NDG and Homes of Hope will develop 22 homeownership units and 21 rental units. A total of 8 rental units will serve families at 50% and 60% Area Median Income (AMI). Homeownership units will have sale prices from \$220,000 to \$240,000 for 3-bedroom units. The development of townhomes and single-family housing will be consistent with the Northside Transformation Plan and will require Design Review Board (DRB) review and approval for the attached townhome rental developments.

AN ORDINANCE AUTHORIZING THE CITY MANAGER
TO EXECUTE AN AGREEMENT FOR THE TRANSFER OF SEVERAL SCATTERED
SITE PROPERTIES LOCATED IN THE NORTHSIDE NEIGHBORHOOD

WHEREAS, the city of Spartanburg (herein after the “City”) has, in certain instances, partnered with non-profit developers to build housing in the City; and

WHEREAS, the City has acquired, through donation or purchase, the following parcels of property, to wit: 375 Arch Street (7-11-08-161.00); 455 Brawley Street (7-12-05-341.00); 465 Brawley Street (7-12-05-169.00); 779 Leonard Street (7-11-04-110.00); 438 N. Forest Street (7-12-09-025.00); 333 Preston Street (7-12-05-002.01); 668 Saxon Avenue (7-11-08-066.00); 670 Saxon Avenue (7-11-08-066.01); 672 Saxon Avenue (7-11-08-067.01); 674 Saxon Avenue (7-11-08-067.00); 254 Franklin Street (7-11-04-206.01), (herein after collectively the “Properties”); and

WHEREAS, several properties were acquired by the City using the South Carolina State Housing Finance and Development Authority (herein after “SC Housing”) – Neighborhood Stabilization Program Funds (herein after “NSP Funds”); and

WHEREAS, Spartanburg City Council deems it advisable and beneficial for the public good to convey the Properties to the Northside Development Group (herein after “Developer”) for the development of affordable and mixed income homeownership and rental development; and

WHEREAS, Developer has engaged a team to improve the housing in the area in the immediate vicinity of the Properties.

NOW THEREFORE, BE IT ORDAINED by the Mayor and Members of Council of the City of Spartanburg, South Carolina, in Council assembled:

Section 1. The City Manager is hereby authorized to (1) enter into a development agreement in substantially the same form as that development agreement attached hereto and marked as Exhibit 1, with minor edits as he, in consultation with the City Attorney deem necessary, and (2) execute an option and any other documents necessary for the transfer of the Properties to the Developer.

Section 2. That no current appraisal is required pursuant to Chapter 2, Article VII, Section 2-262 of the Code of Ordinances of the City of Spartanburg.

Section 3. The City of Spartanburg will enter into a development agreement with the Developer for the transfer and development of the property.

Section 4. The Developer will complete its due diligence to determine the feasibility and complete the development concept within one hundred eighty (180) days of council approval.

Section 5. The City Manager is authorized to sign the necessary documents to execute this transaction.

Section 6. This Ordinance shall become effective upon the date of enactment.
